Overview of Position

The StAMPS assessment is an oral assessment in which the candidate is presented 8 realistic rural medicine scenarios and is assessed for Core Generalist Training (CGT) and Advanced Skills Training (AST).

StAMPS assessment aims to assess higher order thinking skills in a highly contextualised framework. It assesses the clinical reasoning, the application of knowledge in the clinical context and communication skills of candidates.

The Examiner (StAMPS) plays an integral part of the StAMPS assessments and will be supported by the Lead Examiner and Assessment teams in all aspects of the preparation and delivery of each assessment including training and mentoring as required.

Duties and Responsibilities

Preparation:

- Be familiar with the StAMPS assessment processes and ensure current knowledge and understanding.
- Be knowledgeable of the relevant Curriculum (CGT and / or AST) and learning outcomes required for Fellowship of ACRRM.
- Contribute to the development of scenarios and standard setting as per process.
- Ensure any query or process clarifications are resolved in contact with the relevant Lead Examiner in a timely manner and regular contact with the assessment team is kept.
- Provide frequent availability as per
- Complete StAMPS documentation, as per process.
- Attend in the moderation and pre-exam briefing sessions as required.
- Complete the required examiner training for the relevant assessment activity.

Examinations & Assessment:
