Foreword

ACRRM and EVGPT have worked to co-design this plan for the transition of the Australian General Practice Training (AGPT) program from EVGPT to ACRRM at the end of January 2023.

Both parties have agreed to use the contents of this plan to inform internal and external communication, resources and mutual accountabilities. The collaboration and goodwill shown during the plan's development will help ensure a smooth process for all concerned, including those residing within rural and remote communities.

The transition plan is a living document. Both parties expect that there may be changes over time to activity timelines due to changes in external factors or as implementation is undertaken. Any changes will be by mutual agreement.

Transition Analysis

Option	Description	Opportunities	Risks	Comments
Transition of all registrars at a single point in time 1 February 2023	Clear transition date by which all registrars will have all elements of their training in the AGPT program administered/delivered by ACRRM	Clarity of timing and clear point of transition. Alignment to financial and academic year. Allows sufficient time to bring registrars across to ACRRM in a consistent manner. Allows time for funding levels to be determined and DoH to contract ACRRM. Allows for joint placement process with EVGPT and ACRRM minimising disruption. Allows for alignment with ACRRM training term and registrar cohorts. Allows for stronger collaboration.	Communication on reasons for delays and timelines to be considered. A further delayed timeline for transition than anticipated.	This is the preferred approach for ACRRM and allows for both EVGPT's concerns around registrar welfare and for earlier transition preparation to occur. The interest of the registrars in training is paramount and this approach will account for key timelines such as placement management in 2023 Under this model, registrars could be offered key induction offerings and points of contact as early as November to ease processes across. Allows EVGPT and ACRRM to collaboratively work together in the time leading up to the transition date. Handover of registrar management data provides smooth transition as AGPT registrars can commence in line with RGTS/IP training programs in February 2023. Noting EVGPT has stated the majority of data will be taken from the DoH Dataset files. Accounting for transition of Practice and registrar payments through Services Australia from 1 February 2023.EVGPT payments to registrars, practices and supervisor will be finalised by the end of semester 2.2022. Thereafter ACRRM will take responsibility for practice contracts and payments.
