#### **Foreword**

ACRRM and James Cook University (JCU) have worked to co-design this plan for the transition of the Australian General Practice Training (AGPT) program. We have agreed to a transition into Partnership between ACRRM and JCU for delivery of College Led Training across rural Queensland.

JCU will continue as a training delivery entity in 2023; therefore, both parties have agreed to work together to ensure that JCU staff and structures can support and deliver the ACRRM Fellowship Program within a College systems framework. The contents of this plan inform the internal and external communication, resources and mutual accountabilities for these deliverables.

The transition plan is a living document. Both parties expect that there may be changes over time to activity timelines due to changes in external factors or as implementation is undertaken. Any changes will be by mutual agreement.

## **Transition Analysis**

Option	Description	Opportunities	Risks	Comments
Partnership for key training delivery to JCU for registrars at a single point in time 1 February 2023	Clear transition date by which all registrars will have all elements of their training in the AGPT program administered/delivered by ACRRM- through the proposed JCU contracting model. Under this model JCU will have ACRRM dedicated staff to deliver key training functions in QLD.	Clarity of timing and clear point of transition and partnership with JCU for CLT delivery.  Alignment to financial and academic year.  Allows sufficient time to bring JCU staff and in turn ACRRM registrars across to data systems in a consistent manner.  Allows time for funding levels to be determined and DoH to contract ACRRM.  Allows for joint placement process with JCU and ACRRM minimising disruption and bringing JCU registrars into ACRRM placement systems.  Allows for alignment with ACRRM training term and registrar cohorts as well as JCU semester start dates.  Allows for stronger collaboration and recognition of alignments in delivery.  Structured plan facilitates opportunity to communicate roles for clarity of ongoing delivery	Communication on reasons for delays and timelines to be considered.  A further delayed timeline for transition than anticipated.  Confusion in messaging and identification of ACRRM model under JCU banner.  Approach reliant on RACGP-JCU outcomes and agreement.	This is the preferred approach for ACRRM and allows for both JCU's concerns around registrar welfare and for earlier transition preparation to occur.  The interest of the registrars in training is paramount and this approach will account for key timelines such as placement management in 2023  Under this model, registrars could be offered key induction offerings and points of contact as early as October/ November to ease processes across.  Allows JCU and ACRRM to collaboratively work together in the time leading up to the transition date.  December handover of registrar management data provides smooth transition as AGPT registrars can commence in line with RGTS/IP training programs in February 2023.  Accounting for transition of Practice and registrar payments through Services Australia in February 2023.Final JCU payments to go ahead up to February 2023, then ACRRM take on practice contracts for the following term.

Flag: Dual pathway registrars will need to have their own considerations and will be managed in line with the Bi- College approach to placement management.
