

DRUG AND ALCOHOL ADDICTION EDUCATION PROGRAM FREQUENTLY ASKED QUESTIONS

Who is the ACRRM Drug and Alcohol Addiction Education (DAAE) Program for?

The DAAE Program is targeted at General Practitioners who are eligible ACRRM Members*.

What is the incentive grants program?

General Practitioners who are ACRRM Members may be eligible to claim an incentive grant following completion of specific DAAE Program training activity requirements.

Incentive grants are based on the level of participation in the ACRRM DAAE Program – thus providing real incentives for increased engagement in training activities.

Training Activity	Eligible Incentive Grant
Face-to-Face Workshop	\$2,700 (excl. GST)
Online Learning Course	\$1,300 (excl. GST)
Webinar Session	\$200 (excl. GST)

General Practitioners who are ACRRM Members may be eligible to claim incentive grants up to a total of \$4,200 (excl. GST) for completing each of the above ACRRM DAAE Program training activities.

General Practitioners who are ACRRM Members will be able to apply to claim the incentive payment for each DAAE Program training activity only once.

Who is eligible to receive an incentive grant?

General Practitioners who are ACRRM Members that successfully complete the specific DAAE Program training activity requirements will be able to apply to claim the relevant incentive grant.

Please note there is a limited number of incentive grants available and it will be managed by a first to complete, first to claim basis.

What can the incentive grant be used for?

The incentive grant may be used to cover travel and accommodation expenses, locum services or lost working hours at your discretion.

When will I receive the incentive grant?

General Practitioners who are ACRRM Members will be able to apply to claim the relevant incentive grant upon completion of specific DAAE Program training activity requirements.

Can I participate in a workshop training activity if I am not an ACRRM Member?

Yes, however you will not be eligible to apply to claim an incentive grant from ACRRM for participating.

Non-Member participation will be at ACRRMs discretion and subject to availability.

I am an RACGP member can I participate in an ACRRM workshop training activity?

Yes, however you will not be eligible to claim an incentive grant from ACRRM for participating.

Participation by RACGP members in the ACRRM DAAE Program will be at ACRRMs discretion and subject to availability.

The RACGP has its own educational offering, the Alcohol and Other Drugs (AOD) GP Education Program.

RACGP Members must contact the RACGP to check if they are eligible to access the RACGP AOD GP

I am a joint member of both the ACRRM and the RACGP, can I participate in the DAAE Program of both Colleges?

No, joint members of both the ACRRM and the RACGP can only participate in the DAAE Program of one College.

I am a joint member of both the ACRRM and the RACGP, can I receive an incentive grant from both Colleges?

No, joint members of both the ACRRM and the RACGP can only apply to claim an incentive grant from one College.

How do I become an ACRRM Member?

I am not a General Practitioner, can I participate in an ACRRM DAAE Program workshop training activity?

Yes, however the education program is targeted at General Practitioners who are ACRRM members and their participation will be prioritised.

Health professional who are not General Practitioners (e.g. Medical Student, Nurse, Practice Manager, Pharmacist) may be able to participate in an ACRRM DAAE workshop training activity at ACRRMs discretion and subject to availability.

Will the DAAE Program training activities be accredited by ACRRM's Professional Development Program?

Yes, the DAAE Program training activities will be accredited for ACRRM's Professional Development Program (PDP) and contribute to requirements for vocational training.
