



TRANSFERS IN TRAINING

1. Purpose

1.1. This policy describes the training pathways transfers that may occur.

2. Application

2.1. This policy applies to registrars training on the Fellowship Training Program.

3. Policy

3.1. Registrars on Remote Vocational Training Scheme (RVTS) or a funded pathway in the Fellowship Training Program may apply for transfer to the Independent Pathway (IP) and vice versa. However:

3.1.1. acceptance is at the discretion of the College

3.1.2. registrars must be withdrawn from one pathway prior to the current pathway prior to the enrolment in next pathway

3.2. Registrars are not able to transfer between funded training pathways

4. Responsibilities

4.1. Registrars are responsible for:

4.1.1. discussing all transfers with the College

4.1.2. submitting transfer applications to the College for transfer to IP

4.2. The College is responsible for approving transfers.
